

## DYCKMAN FARMHOUSE MUSEUM “KEY TO NYC” REQUIREMENTS

The Dyckman Farmhouse Museum, as a business covered by the requirement of “[Key to NYC: Vaccination Required for Indoor Establishments](#),” is required by the City of New York to check the vaccination status of all staff and visitors 5 years of age and older.

People ages 5 to 11 are required to show proof they have received at least one dose of a COVID-19 vaccine. People 12 and older will be required to show proof they have received at least two doses of a COVID-19 vaccine authorized for emergency use by the FDA or WHO.

**An individual who refuses to show proof of vaccination may not enter the museum.** The Dyckman Farmhouse Museum may not permit entry to anyone 5 and older who has not received at least one dose or anyone 12 and older who has not received at least two doses of the COVID-19 vaccine. As of September 13, 2021, an establishment found to be noncompliant may be subject to a fine of \$1,000.

### VALID FORMS OF VACCINATION AND IDENTIFICATION

Proof of vaccination may include:

- NYC COVID Safe App: [Android](#) | [iOS](#)
- [Excelsior Pass](#)
- [CDC Vaccination Card](#) (or photo)
- [NYC Vaccination Record](#)
- An official immunization record from outside NYC or the U.S

If you received the vaccine outside the U.S., you must have an official immunization record that includes:

- First name and last name
- Date of birth
- Vaccine product name (only [vaccines authorized by the WHO](#) are acceptable)
- Date(s) administered
- Site where the vaccine was administered, or name of the person who administered it

A valid form of identification for anyone appearing to be 18 years of age or older will also be checked at the same time we check proof of vaccination for entrance.

Proof of identification must contain either:

- The name of the individual and a photo of the individual; or
- The name of the individual and the individual’s date of birth.

Examples of acceptable forms of identification include but are not limited to: Driver’s license; Non-driver government ID card; IDNYC card; Passport; School or work ID card.

### ACCOMODATIONS AND EXCEPTIONS

The Dyckman Farmhouse Museum is welcoming to individual needs and will consider appropriate reasonable accommodations, mindful of the purposes behind this policy and public health.

Under this new guidance, indoor dining, fitness and entertainment venues must accept valid proof that you received at least one dose of any vaccine authorized for emergency use by the FDA or WHO. This requirement may not be used as an excuse for businesses to discriminate against anyone who has valid vaccination proof.

You have a right to be free from discrimination or harassment. If you believe you have been discriminated against because of who you are, including your race, national origin or disability, contact the [NYC Commission on Human Rights](#).
